1. The Kitchen Maestro competition takes place from Saturday, 8 July to Sunday, 6 August 2017.

4. Six (6) entrants per week will be chosen to participate in the weekly cook-offs and notified telephonically.
5. Once notified, the entrants will have the opportunity to accept. Entrants who fail to be reached telephonically prior to the event will forfeit the opportunity and a replacement finalist will be drawn and notified telephonically.
6. All entrants must be at Walmer Park Shopping Centre by 10h30 on the Saturday of their cook-off event they are selected for. The Cook-off will begin at 11h00.
7. Any costs or expenses which you may incur other than in respect of those specifically included in a prize are for your own account. Walmer Park Shopping Centre will not be responsible for any costs you may incur, including those involved with transport to and from the Centre should you be selected to participate on any given day.
8. Two entrants will be chosen per week to take part in the semi-finals which will take place on Saturday, 5th August 2017. Should any entrant not be able to attend, their place will be forfeited and an alternate entrant selected.
9. Two finalists will be chosen on Saturday, 5th August 2017 to compete in the final event which will take place on Sunday, 6th August 2017. The entrants must confirm their availability for the finals.
